I. Aims and objectives

- 1. To promote the music of various genres, to promote its performance in Lithuania.
- 2. To foster and develop the traditions of ensembles of young performers.
- 3. To strengthen the links between the international musical community, the development of joint concert activities, creative cooperation between young performers and their teachers.
- 4. To enable young performers to participate in the international event.

II. Rules of the Competition

- 1. Chamber ensembles from Lithuanian and foreign conservatoires, universities, music, art and secondary schools, other educational institutions are welcome to take part in this competition.
- 2. Participants are divided in 2 categories:
 - Those participating directly
 - Those participating remotely
- 3. Participants participating directly or remotely must perform two (2) freely chosen pieces of different character and stylistic period.
- 4. The cast of chamber instrumental ensembles:

<u>Piano and:</u>

- String instrument(s)
- Wind instrument(s)
- Accordion(s)
- Other instrument(s)
- 5. Number of performers in the chamber instrumental ensemble:
 - Duo
 - Trio
 - Quartet
 - Quintet
- 6. Participants age groups (by the age of the eldiest participant of the ensemble):

A gr. (born on 01/05/2014 and later)

- B gr. (born on 01/05/2011 30/04/2012)
- C gr. (born on 01/05/2008 30/04/2009)
- D gr. (born on 01/05/2004 30/04/2006)
- 7. Dalyvių pasirodymų eilės tvarka grupėje sudaroma **pagal jaunesniojo ansamblio dalyvio gimimo datą**. The order of performances in the auditions is based on the date of birth of the youngest participant in the ensemble.
- The schedule of rehearsals and auditions will be drawn up after the application deadline, published on the school's website www.nvmm.lt no later than 2024. May 10.

III. Procedure for organizing the Competition

- 1. Date of the Competition: May 18-19, 2024
- 2. Deadline to apply for participating remotely is 01/05/2024. Participants must provide:
 - Application form (<u>https://www.nvmm.lt/artimiausi-renginiai/konkursai-festivaliai/registracija-konkursai-festivaliai/</u>);
 - A link to the video placed in the YouTube platform;
 - Copies of the participant's fee approval.
- 3. Ways of submission of participants' videos:
 - Both pieces can be recorded immediately;

- Both pieces can be recorded separately. It is recommended to merge the recordings into one video link. In this case it is compulsory to make both recordings in the same place and wearing the same clothes.
- 4. Requirements for the video recording:
 - Video recording must be of good quality;
 - Video recording must be placed in youtube platform;
 - Title of the video "MUSICA BRILLANTE 2024";
 - Description of the video: names, surnames of the participants, country, program;
 - The visibility of the video should be PUBLIC;
 - Submitting the application participants agree that their records are placed in the public area.
- 5. Deadline to apply for participants participating directly is 05/05/2024. Participants must provide:
 - Application form (<u>https://www.nvmm.lt/artimiausi-renginiai/konkursai-festivaliai/registracija-konkursai-festivaliai/</u>);
 - Copies of the participant's fee approval.
- 6. The performances of the participants will be evaluated by the jury, the members of which are invited by the organizing committee.
- 7. Participating fee is **15 EUR** for each member of the ensemble.

- 2. Participants' performances are evaluated using a 25-point system.
- 3. By the decision of the jury, the following are appointed:
 - Diplomas of the Laureates of 1st, 2nd, 3rd Prize
 - Diplomas
 - Letters of gratitude.
 - According to the jury's decision, the chamber instrumental ensemble with the highest points will be awarded the **GRAND PRIX**.
 - Teachers are awarded the letters of gratitude.
- 4. Organizations and individuals may establish special prizes.
- 5. The organizers reserve all rights to the audio and video recordings of the auditions and the final concert, radio and TV broadcasts and publications (articles, reviews,

photos, etc.) in the press without compensation for the participants for an unlimited period of time.
